- 1) ALL COACHES: Will follow CCYFL / NYSCA / USA Football guidelines for instruction of players, including practice and games, acting in the best interest of the participants. \_\_\_\_\_ *initials*
- 2) Will be reasonable in demands on player’s time, energy and enthusiasm. Will consider the maturity level of the players in scheduling practice times and games. \_\_\_\_\_ *initials*
- 3) Will teach players that the rules of the game are mutual agreements which no one should evade or break. Will promote team respect for the ability of opponents, as well as the judgment of officials and all opposing coaches. \_\_\_\_\_ *initials*
- 4) Will minimize the possibility of serious injury by ensuring proper equipment and training. Will follow the advice of qualified physician(s) when determining if an injured player is ready to return . \_\_\_\_\_ *initials*
- 5) Will give every player an opportunity to PLAY and to develop their skills. \_\_\_\_\_ *initials*
- 6) Will stress playing for the fun of skill development and enjoyment of competition, and winning is only part of the experience. \_\_\_\_\_ *initials*
- 7) Will be generous with praise and will set a good example that all children will respect. \_\_\_\_\_ *initials*
- 8) Will make a personal commitment to keep informed on sound coaching principles and the benefits of team sports participating in the growth and development of children. \_\_\_\_\_ *initials*
- 9) Will be responsible for the correct birthdate and correct permanent address being shown on the player’s agreement/contract. \_\_\_\_\_ *initials*
- 10) Will be responsible for the conduct of the team’s fans. \_\_\_\_\_ *initials*
- 11) Will be responsible for ‘Authorized Filming’ of game and is subject to disciplinary actions by CCYFL if filming rules are violated. \_\_\_\_\_ *initials*
- 12) A coach will be prohibited from the following at any youth football practice, game or on any youth football field while a CCYFL coach; **Consume alcoholic beverages, use any tobacco product, use profane language, use improper conduct which includes, but is not limited to, verbal or physical assault and/or harassment of officials, players, parents, fans of the opposing football staff.** \_\_\_\_\_ *initials*
